### **IPPII** ASSISTANCE PROGRAMS









OPPD's Energy Assistance Program (EAP) provides important support for customers experiencing financial hardships and is managed in partnership with the Dollar Energy Fund and local community agencies.

- Up to \$500 per year in bill payment assistance
- · Eligibility for residential customers with total household income at or below 200% of the Federal Poverty Level
- Assistance tailored to those experiencing emergencies, such as medical crises, job loss, , or other financial issues
- Must have a past due balance on their OPPD account





#### **CUSTOMER ASSISTANCE PROGRAM**

OPPD's Customer Assistance Program (CAP) offers ongoing, monthly bill credits to help income-qualified customers manage their energy costs.

- \$40 a month bill credit for households up to 50% of Federal Poverty Level (FPL) or \$30 a month bill credit for households between 51% and 100% of Federal Poverty Level (FPL)
- · Must be current on your OPPD account or have a pledge to make account current
- Recertify eligibility annually or with any change in household size or income must be reported within 10 business days

# **ENERGY EFFICIENCY ASSISTANCE PROGRAM**

OPPD's Energy Efficiency Assistance Program (EEAP) helps you make efficient improvements to your home and connect you with knowledgeable professionals.

- Provide a **complimentary in-home energy assessment** to identify areas for energy-efficiency upgrades. We then determine which upgrades best qualify for **up to \$3,000 in improvements**, implemented by contractor partners like Habitat for Humanity of Omaha, United Way of the Midlands, Project Houseworks, Southeast Nebraska Community Action Partnership (SENCA), etc
- · Eligibility for residential customers with total household income below 200% Federal Poverty Level (FPL) see reverse
- · Renters of properties with eight or fewer units may apply with written permission from their landlord/property owner

#### LOW-INCOME HOME ENERGY ASSITANCE PROGRAM

Low-Income Home Energy Assistance Program (LIHEAP) is a federal funded program administered by the Nebraska Department of Health and Human Services (DHHS) helps families afford the electricity needed to stay warm during the winter, cool in the summer and keep the lights on.

- · LIHEAP can help with the following:
  - Heating Assistance Cooling Assistance
- Crisis Assistance
- Window A/C Purchase Assistance
- Weatherization Services
- Furnace & A/C Repair or Replacement
- Up to \$750 for Furnace and Central A/C Repair and Replacement Assistance. Up to \$5,000 for Heating and Cooling Repair and Replacement Assistance through Nebraska Department of Water, Energy, and Environment
- Eligibility for residential customers with total household income at or below 150% Federal Poverty Level (FPL)
